...WINTER STORM WARNING IN EFFECT FROM 1 AM THURSDAY TO MIDNIGHT THURSDAY NIGHT...

- * WHAT...Heavy snow and blowing snow expected. Blizzard conditions possible. Plan on difficult travel, including during the morning and evening commutes on Thursday. Total snow accumulations of 6 to 10 inches are expected, with higher amounts in excess of one foot possible.
- * WHERE...Suffolk County.
- * WHEN...From 1 AM Thursday to midnight EST Thursday night.
- * ADDITIONAL DETAILS...Winds gusting as high as 45 to 50 mph will cause areas of blowing and drifting snow. Several tree limbs and power lines may be downed, which could cause scattered power outages.

PRECAUTIONARY/PREPAREDNESS ACTIONS...

A Winter Storm Warning for snow and blowing snow means severe winter weather conditions are expected. If you must travel, keep an extra flashlight, food and water in your vehicle in case of an emergency. The latest road conditions for the state you are calling from can be obtained by calling 5 1 1.
