***RESIDENT PARKING PERMIT APPLICATION***  
***(Expires Annually on January 31<sup>ST</sup>)***

1. **RESIDENT PARKING PERMITS (\$35.00):** Entitles purchaser to park in the following municipal lots:
  - **Locust Avenue Lot** in the **un-numbered** spaces-South side of Locust just west of the Little League Field.
  - **James Street Lot** in the **un-numbered** parking spaces behind the stores on Deer Park Avenue in the lot off James Street (SOME SPACES MAY STATE 2 HR LIMIT-- DOES NOT APPLY WITH THIS PERMIT.)
  - **George Street Lot**--without paying the meter.
  
2. **METERS IN THE SHOPPING DISTRICT WITH A 2 HOUR LIMIT ARE NOT INCLUDED. YOU MUST PAY THE METER.**
  
3. **IF YOU PARK IN THE LOTS ON THE SOUTH SIDE OF THE RAILROAD TRESTLE, YOU MUST PAY THE METER.**
  
4. **YOU ARE NOT ENTITLED TO PARK IN THE LOTS ON THE NORTH SIDE OF THE TRESTLE--THESE ARE RESERVED PARKING SPACES.** (You must file a separate application to be placed on the wait list for these lots.)

Village Code states that *decals should be placed on the left rear bumper so as to be clearly visible.*  
***DECALS ARE NOT TRANSFERABLE. Any decal put on a vehicle other than the one on file will be void and will subject the permit holder and the vehicle owner to a summons.***

All vehicles without decals or those parked in areas other than where they are assigned will be issued tickets by the Suffolk County Police and Special Officers of Babylon Village. Fines are ONE HUNDRED (\$100) dollars and illegally parked vehicles are subject to being towed and stored. The fee for towing is at least an additional one hundred fifty (\$150) dollars, plus a storage charge.

The purpose of this law and the \$100.00 fine is not to raise revenue, but to dissuade non-permit holders from parking in areas where permit holders are allowed to park. Signs are posted at all lots to warn away illegal parkers. Your cooperation is appreciated. Thank you.
